To give consideration to the feasibility of the parish council taking action to rectify damaged areas of highway/verge along Church Road and School Lane. See Chairman's attached suggestion and costs as to how this could be achieved.

Request for materials to enable some repairs to the verges in Church Road and School Lane

In the ongoing efforts of the community work party to improve the general state of the village, myself and Councillor Witton would like to explore repairing the very muddy area in Church Road, next to start of the footpath leading towards the foot bridge (closed at present) this small area by the entrance is also a parking area for those who use this path, park to go to the church, and also where WSC park when they empty the dog bin there. After scraping away the mud after local residents had said there was once a hard standing there, the remains of this standing were found.

School Lane has a section just past Skinners Lane, which has been severely damaged by vehicles parking.

Proposal to purchase some tarmac road plainings from Steve Lumley Ltd in Bury St Edmunds, two options:

- 1. 15mm which is finer £27.50 per tonne delivered
- 2. 55mm which is a lot coarser £25.50 per tonne delivered
- 3. Hire of a wacker to compact the materials down £ 36.23 plus fuel.

All above prices are plus vat

Regardless of what size plainings are required, would need 10 tonne to cover both areas mentioned.
